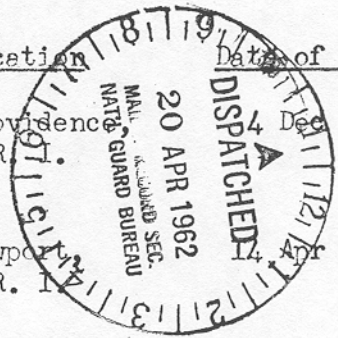

3. Priority aggregate strength and sequence of organization will be as prescribed in Organization and Equipment Guides. Priority and percent of manning are as follows:


